The applicant Shelby K. Guelich (agent for owner C. Dennis Jantz), hereby makes application for permission to change the Point of Diversion of water heretofore appropriated under Permit number 49753

1. The source of water is underground
2. The amount of water to be changed 4.7 second feet
3. The water to be used for irrigation
4. The water heretofore permitted for irrigation
5. The water is to be diverted at the following point SE corner of the NE $\frac{1}{4}$ of the SE $\frac{1}{4}$ Section 21 T.19N. R47E MDB&M (parcel 2 of Shelby K. Guelich parcel map recorded Mar. 23, 1982, file # 111755, Lander County, Nevada.
6. The existing permitted point of diversion is located within Parcel #3 of said Shelby K. Guelich parcel map (NW $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 21 T19N R47E, MDB&M)
7. Proposed place of use S $\frac{1}{2}$ of the N $\frac{1}{2}$, N $\frac{1}{2}$ of the S $\frac{1}{2}$ of Sec. 21 T19N R47E MDB&M
8. Existing place of use Parcel #5 of Shelby K. Guelich parcel map (above) for irrigation
9. Use will be from Jan 1 to Dec 31 of each year.
10. Use was permitted from Jan 1 to Dec 31 of each year.
11. Description of proposed works Well, 24" diameter hole 16" casing estimated depth 300 ft.
12. Estimated cost of works \$29,000.
13. Estimated time required to construct works 12 months
14. Estimated time required to complete the application of water to beneficial use 60 days

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This temporary permit to change the point of diversion of a portion of the waters of an underground source as heretofore granted under Permit 49753 is issued subject to the terms and conditions imposed in said Permit 49753 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a measuring device must be installed in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 49753 and 63285-T shall not exceed 1,280.0 acre-feet annually.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire on September 7, 1998 at which time all rights herein granted shall revert to the right being changed by this temporary permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 4.7 cubic feet per second, and not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before:
