The applicant **Bennie J. Damonte and Eva Damonte**, hereby make application for permission to change the **Point of Diversion** of water heretofore appropriated under **all of Permit 27610, Certificate 9676**

1. The source of water is **the Truckee River**
2. The amount of water to be changed **0.15 cfs, 48.00 afa**
3. The water to be used for **Irrigation, stock watering and domestic, as decreed**
4. The water heretofore permitted for **Irrigation, stock watering and domestic, as decreed**
5. The water is to be diverted at the following point within the **NE 1/4 of the SW 1/4 of Section 31, T.19N., R.18E., M.D.M.** or at a point from which the **SE corner of said Section 31** bears **South 62°04' East** a distance of **3195.00 feet**. **Steamboat Canal per Orr Ditch Decree. See Map No. 58679.**
6. The existing permitted point of diversion is located within the **SE 1/4 of the NE 1/4 of Section 14, T.19N., R.18E., M.D.M.**, or at a point from which the **NW section corner of Section 13, T.19N., R.18E.**, bears **North 24°26' East** a distance of **1840.00 feet**. **Last Chance Ditch per Orr Ditch Decree. See Map No. 58810.**
7. Proposed place of use **Place of use is not changed.**
8. Existing place of use **20.3 acres in the NW 1/4 of the NE 1/4, 6.9 acres in the NE 1/4 of the NE 1/4 and 2.3 acres in the SW 1/4 of the NE 1/4 of Section 21; 37.1 acres in the SW 1/4 of the SW 1/4, 17.3 acres in the SE 1/4 of the SW 1/4 and 3.5 acres in the SW 1/4 of the SE 1/4 of Section 15; all in T.18N., R.20E., M.D.M.. 87.4 acres total.**
9. Use will be from **As Decreed** to of each year.
10. Use was permitted from **As Decreed** to of each year.
11. Description of proposed works **Existing.**
12. Estimated cost of works
13. Estimated time required to construct works **Completed.**
14. Estimated time required to complete the application of water to beneficial use **1 year**

15. Remarks: The reason for this change is that due to the construction of the interchange at Zolezzi Lane and development on the northeast corner of the Damonte Ranch, it is now impossible to divert water from the Last Chance Ditch to the place of use. (See attached letter.) An Application to Change this right permanently will be filed within one year of issuance of the temporary permit.

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This temporary permit to change the point of diversion of the waters of the Truckee River as heretofore granted under Permit 27610, Certificate 9676 which changed the place of use of the waters of the Truckee River as heretofore granted under Permit 12337, Certificate 3648 which changed the point of diversion and place of use of a portion of Claim No. 431, Truckee River Decree is issued subject to the terms and conditions imposed in said decree and with the understanding that no other rights on the source will be affected by the change proposed herein. A suitable measuring device must be installed and accurate measurements of water placed to beneficial use must be kept.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire on August 17, 1999 at which time all rights herein granted shall revert to the right being changed by this temporary permit.


