The applicant FRONT SIGHT MANAGEMENT, INC., hereby makes application for permission to change the Point of Diversion, Place and Manner of Use of water heretofore appropriated under Permit 62446

\*\*\*\*\*

1. The source of water is Underground
2. The amount of water to be changed 0.233 cfs N.T.E. 95.0 AFA
3. The water to be used for Municipal
4. The water heretofore permitted for Municipal & Domestic
5. The water is to be diverted at the following point SW $\frac{1}{4}$  SW $\frac{1}{4}$  Section 14, T.22S., R.54E., M.D.B.&M., or at a point from which the SW corner of said Section 14 bears S. 61° 07' 24" W., a distance of 1135.0 feet.
6. The existing permitted point of diversion is located within SW $\frac{1}{4}$  SE $\frac{1}{4}$  Section 19, T.20S., R.53E., M.D.B.&M., or at a point from which the S $\frac{1}{4}$  corner of said Section 19 bears S. 23° 40' 57" W., a distance of 1328.17 feet. (Well #1)
7. Proposed place of use Portions of the SW $\frac{1}{4}$  SW $\frac{1}{4}$  & NW $\frac{1}{4}$  SW $\frac{1}{4}$  Section 14; Portions of the SE $\frac{1}{4}$ , NE $\frac{1}{4}$ , NW $\frac{1}{4}$  & SW $\frac{1}{4}$  Section 15; Portions of the SE $\frac{1}{4}$  & NE $\frac{1}{4}$  Section 16; Portions of the NE $\frac{1}{4}$  & NW $\frac{1}{4}$  Section 22, all within T.22 S., R.54E., M.D.B.&M. (Tract 38)
8. Existing place of use SE $\frac{1}{4}$  Section 19; and the W $\frac{1}{2}$  of the SW $\frac{1}{4}$  Section 20, all within T.20S., R.53E., M.D.B.&M.
9. Use will be from January 1st to December 31st of each year.
10. Use was permitted from January 1st to December 31st of each year.
11. Description of proposed works drilled and cased well, pump, motor, storage tank and distribution system.
12. Estimated cost of works \$700,000.00
13. Estimated time required to construct works completed under Application 64435, W-504
14. Estimated time required to complete the application of water to beneficial use Five (5) years
15. Remarks: Water to be used for training school facilities serving up to 500 students. Additional facilities will consist of five

residences and an R.V. Park with 50± spaces. Restroom facilities will be provided throughout the training site.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion, place of use and manner of use of the waters of an underground source as heretofore granted under Permit 62446 issued subject to the terms and conditions imposed in said Permit 62446 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The total combined duty of water under Permits 64434, 64435, 64832, 64833 and 64834 shall not exceed 501.0 acre-feet annually.

If any water under this permit is cancelled, withdrawn, or any water is not put to beneficial use, it will revert to the groundwater source and not back to the base water right.

Monthly records shall be kept of the amount of water pumped from this well and the records submitted to the State Engineer on a quarterly basis within 15 days after the end of each calendar quarter.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.233 cubic feet per second, **but not to exceed 95.0 acre-feet annually.**


