The applicant **DAVID LITTLE AND SHERRY LYNN LITTLE** hereby make application for permission to change the **PLACE OF USE** of water heretofore appropriated under **PERMIT NO. 45288**

1. The source of water is **AN UNDERGROUND SOURCE**
2. The amount of water to be changed **4.0 C.F.S.**
3. The water to be used for **IRRIGATION AND DOMESTIC USE**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the place of use of the waters of an underground source as heretofore granted under Permit 45288 is issued subject to the terms and conditions imposed in said Permit 45288 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The total combined duty of water under Permits 65208, 65209, 65210, 65211, 66913, and 66914 shall not exceed 2,480.0 acre-feet annually.

This permit is issued with the understanding that the permittee will accurately measure, on a weekly basis, the static or pumping level of the wells described under this permit and Permit 21921. These records must be submitted to the State Engineer and to the owner of the well described under Permit 21921 on an annual basis.

This permit is issued with the understanding that the pump will be set at a level of 140 feet.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 4.0 cubic feet per second, but not to exceed 2,080.0 acre-feet annually, and not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before:

May 11, 2002

Proof of completion of work shall be filed before:

June 11, 2002

Water must be placed to beneficial use on or before:

May 11, 2003

Proof of the application of water to beneficial use shall be filed on or before:

June 11, 2003


