The applicant Central Nevada Utilities Company, hereby makes application for permission to change the Point of Diversion, Place and Manner of Use of a portion of water heretofore appropriated under Permit 54405

- 1. The source of water is Underground - Well No. 11
2. The amount of water to be changed 0.1494 c.f.s., 87.2 AFA
3. The water to be used for Municipal
4. The water heretofore permitted for Irrigation
5. The water is to be diverted at the following point SW 1/4 SE 1/4 Section 14, T.20E., R.53E., MDM, or at a point from which the SE corner of said Section 14 bears South 76°58'34" East, 2216.06 feet
6. The existing permitted point of diversion is located within NE 1/4 NW 1/4 Section 3, T.20S., R.53E., MDM, or at a point from which the N 1/4 corner of said Section 3 bears North 45° East, 100.0 feet
7. Proposed place of use See attached
8. Existing place of use within the NW 1/4 SW 1/4, NE 1/4 SW 1/4 Section 3, T.20S., R.53E., MDM, 17.44 acres to be removed from irrigation with this application
9. Use will be from January 1 to December 31 of each year.
10. Use was permitted from January 1 to December 31 of each year.
11. Description of proposed works drilled well, pump and motor, and municipal water distribution system
12. Estimated cost of works existing
13. Estimated time required to construct works existing
14. Estimated time required to complete the application of water to beneficial use 10 years

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion, place and manner of use of a portion of the waters of an underground source as heretofore granted under Permit 54405 is issued subject to the terms and conditions imposed in said Permit 54405 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

If any water under this permit is cancelled, withdrawn, or any water is not put to beneficial use, it will revert to the groundwater source and not back to the base water right.

Monthly records shall be kept of the amount of water pumped from this well and the records submitted to the State Engineer on a quarterly basis within 15 days after the end of each calendar quarter.

The total combined duty of water under Permits 38343, 45870, 45892, 45893, 45894, 45895, 45897, 46116, 46117, 46118, 46119, 46304, 46305, 46306, 46307, 46308, 46309, 46310, 46312, 46313, 46314, 46315, 46316, 46317, 46318, 46319, 46320, 46324, 46325, 46326, 46826, 46827, 47074, 47141, 47265, 48497, 49545, 50722, 50804, 50805, 51142, 52128, 52129, 52130, 52131, 52132, 52284, 52285, 52606, 52978, 54357, 54359, 54360, 54361, 55101, 55347, 57877, 57879, 57880, 58626, 58627, 58628, 58629, 58630, 58631, 58632, 58633, 58958, 58959, 60694, 60695, 61064, 61065, 61188, 61968, 61969, 62037, 62038, 62716, 62717, 62726, 62727, 62920, 63500, 63780, 64364, 64365, 64366, 64367, 64615, 65104, 65735, 66228, 66239, 66481, 66482, 66938, 69131, 71196, 71197, 71198, 71199, 71201, 71750, 71751, and 71752 shall not exceed 21090.705 acre-feet annually.

Any will serve commitments issued from this permit for single family residential units will be based on an allocation of 1.12 acre-feet per unit. Any other allocation under this permit will require a dedication equivalent to a 43% increase over that of the planned use.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.1494 cubic feet per second, and not to exceed 87.2 acre-feet annually.

Work must be prosecuted with reasonable diligence and be completed on or before:
March 3, 2007

Proof of completion of work shall be filed on or before:
April 3, 2007

Water must be placed to beneficial use on or before:
March 3, 2016

Proof of the application of water to beneficial use shall be filed on or before:
April 3, 2016
