#### APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of the waters of an underground source as heretofore granted under Permit 66342, Certificate 16442 is issued subject to the terms and conditions imposed in said Permit 66342, Certificate 16442 and with the understanding that no other rights on the source will be affected by the change proposed herein. This well shall be equipped with a two (2) inch opening for measuring depth to water and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

Monthly records shall be kept of the amount of water pumped from this well and the records submitted to the State Engineer on a quarterly basis within 15 days after the end of each calendar quarter.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The well must be sealed with cement grout, concrete grout or neat cement from ground level to 100 feet.

The total combined duty of water under Permits 67307, 68337, 68338, 68792, 68793, 68794, 68795, 68796, 68797, 71076, 71077, 71078, 71079, 71950, 72264, 77409, 77410, 77411, 77412, 77413, and 77414 shall not exceed 680.64 acre-feet annually. Permits 68337 and 68338 are Sierra Canyon Creek infiltration wells; Permit 68792 can only be pumped when there is no surface water from 68337 and 68338.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The point of diversion and place of use are as described on the submitted application to support this permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.00155 cubic feet per second or 1.12 acre-feet annually.



The applicant, **Douglas County, PO Box 218 of Minden, NV 89423**, hereby makes application for permission to change the **Point of Diversion and Place of Use** of water heretofore appropriated under **Permit 66342, Certificate 16442**.

1. The source of water is: **an underground source.**
2. The amount of water to be changed: **0.00155 cfs (1.12 afa / 0.365 mga).**
3. The water to be used for: **No Change.**
4. The water heretofore used for: **Quasi-Municipal.**
5. The water is to be diverted at the following point: **Within the SW 1/4 of the SE 1/4 of Section 15, Township 13 North, Range 19 East, M. D. B. & M., or at a point from which the South 1/4 corner of said Section 15 bears S 05° 26' 00" W, a distance of 1125.00 feet. (Walley's Hot Springs Well # 2). Estimated time required to construct works: **Completed: Improvements consisted of an 8-inch well drilled to 282-foot depth, equipped with a 50-hp Goulds 7CHC 3-stage pump, Serial No. FR488522, a Franklin 6-inch 460 volt 3-phase motor, Serial No. 04419, a Siemens MagFlo totalizing meter, Serial No. 7ME651035801T424. Reading on date of installation (February 21, 2005) was zero (0).**
14. Estimated time required to complete the application of water to beneficial use: **8 - 10 years.**
15. Remarks: **Sierra Shadows Well No. 1 is being abandoned due to the structural failure of the well and plugging of the screen resulting in a significant loss of production. The water rights in the well are being moved to the Walley's Well No. 2 within the West Valley Water System.**
