The applicant filed applications 65823 thru 65864 changing the point of diversion and place of use to be able to drill 16 new wells and irrigate 3300 acres. The applicant has drilled 7 of the wells and has changed the points of diversion of 7 of the remaining wells to the existing 7 wells. The applicant is now changing the points of diversion for the last 2 wells to the existing 7 wells. The applicant intends to irrigate the entire 3300 acres from the existing 7 wells.
