## THE STATE OF NEVADA CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS James A. Rankin, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from \_\_\_\_\_ an Underground Source through \_\_\_\_\_ a drilled well, pump and distribution system \_\_\_\_\_ for \_\_\_\_\_ Irrigation and Domestic purposes. The point of diversion of water from the source is as follows: SW $\frac{1}{4}$  NE $\frac{1}{4}$  Section 17, T.17N., R.23E., M.D.B.&M. or at a point from which the E $\frac{1}{4}$  corner of said Section 17 bears S. 84° 06' 48" E., a distance of 1742.0 feet situated in Lyon County, State of Nevada.

Now KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Description of: land to which the water is appurtenant:

3.0 acres in the SW $\frac{1}{4}$  NE $\frac{1}{4}$  of Section 17, T.17N., R.23E., M.D.B.&M.

\*This certificate changes the point of diversion and place of use of a portion of Permit 31040, Certificate 9187, which changed the point of diversion and place of use of Permit 30168, which changed the point of diversion and place of use of a portion of Permit 27817, Certificate 9178, which changed the point of diversion of Permit 26675, hence the date of priority of appropriation remains the same as Permit 26675.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre per year from any and all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
