CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Chris Tschirhart, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source through a drilled well, pump and distribution system for quasi-municipal purposes. The point of diversion of water from the source is as follows:

SW¼ NW¼ Section 10, T.13N., R.19E., M.D.B.&M., or at a point from which the NW corner of said Section 10 bears N. 05° 11' 20" W., a distance of 2515.32 feet situated in Douglas County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator: Sierra Shadows, A Joint Venture

Source: Underground

Manner of Use: Quasi-Municipal

Amount of appropriation: 0.145 c.f.s., but not to exceed 1.825 million gallons annually

Period of use: January 1st to December 31st of each year

Date of priority of appropriation: *May 6, 1977

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well 175 feet deep, 8 5/8 inch casing, via a 7½ H.P. submersible pump, thence through a distribution system, including a 60,000 gallon tank, to 25 houses, a restaurant, a pool and tennis courts for quasi-municipal purposes within the SE¼ NE¼ and NE¼ SE¼ Section 9, and the SW¼ NW¼ and NW¼ SW¼ Section 10, T.13N., R.19E., M.D.B.&M.

*This certificate changes the point of diversion and place of use of Permit 31507, therefore, the date of priority remains the same as Permit 31507.

The total combined duty of water under this certificate and any certificate issued under Permit 42385 shall not exceed 1.825 million gallons annually.

The total combined rate of diversion of water under this certificate and any certificates issued under Permits 42385 and 52731 shall not exceed 0.145 c.f.s.

The total combined duty of water under this certificate and any issued under Permits 42383, 42385 and 52731 shall not exceed 10.138 million gallons annually.

This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
