CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Robert H. Cantley, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source through a drilled well, pump, and distribution system for commercial and domestic purposes. The point of diversion of water from the source is as follows:

SW 1/4 SE 1/4 Section 24, T.16N., R.21E., M.D.B.&M., or at a point from which the SE corner of said Section 24 bears S. 57°02'18" E., a distance of 1,920.0 feet situated in Lyon County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator: Michael W. and Barbara D. Hughes
Source: Underground
Manner of Use: Commercial and Domestic
Amount of appropriation: *0.36 c.f.s., but not to exceed 15.0 million gallons annually
Period of use: January 1st to December 31st of each year
Date of priority of appropriation: **April 10, 1972

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well 494 feet deep, 12 3/4 inch diameter casing, via a 20 H.P. Goulds submersible pump, thence through a 4 inch distribution line to a classifier operation, various sand and gravel wash operations, and into various screening, settling, and dust suppression operations for commercial and domestic purposes located within the SW 1/4 SE 1/4 Section 24, and portions of the SE 1/4 NE 1/4, NE 1/4 SE 1/4 Section 23, and a portion of the NW 1/4 SW 1/4 Section 24, all in T.16N., R.21E., M.D.B.&M.

*The total combined duty of water under this certificate and Permit 39806, Certificate 11277; Permit 51079, Certificate 14167; Permit 51080, Certificate 14168; Permit 51096, Certificate 14169; Permit 51097, Certificate 14170; and any certificates issued under Permit 58801, Permit 58693, and Permit 58694, shall not exceed 41.00 million gallons annually.


**This certificate changes the place of use of Permit 54147 which changed the point of diversion and place of use of Permit 52859, which changed the point of diversion and place of use of Permit 35405, which changed the point of diversion, place of use, and manner of use of Permit 29623, which changed the point of diversion of Permit 26660, therefore, the date of priority remains the same as Permit 26660

This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
