CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Michael D. Buschelman, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source through a drilled well, pump, and distribution system for irrigation and domestic purposes. The point of diversion of water from the source is as follows:

NW¼ SE¼ Section 13, T.21S., R.53E., M.D.B.&M., or at a point from which the E¼ corner of said Section 13 bears N. 87°25'56" E., a distance of 1,360.10 feet situated in Nye County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

 Source: Underground
 Manner of Use: Irrigation and Domestic
 Amount of appropriation: *0.0824 c.f.s., but not to exceed 59.65 acre-feet annually
 Period of use: January 1st to December 31st of each year


*The water under this certificate and any certificates issued under Permits 49716 and 62190 is commingled and the total duty of water is limited to 531.20 acre-feet annually for the irrigation of 106.24 acres.

**This certificate changes the point of diversion of Permit 56719, which changed the point of diversion of Permit 49500, which changed the point of diversion and place of use of a portion of Permit 21056, Certificate 7530, therefore, the date of priority remains the same as Permit 21056, Certificate 7530.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 5.0 acre-feet per acre per annum from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
