CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Teandra Schaefer, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source through a drilled well, pump and distribution system for recreation and domestic purposes. The point of diversion of water from the source is as follows:

SW¹/₄ NW¹/₄ Section 30, T.14N., R.20E., M.D.B.&M., or at a point from which the NW corner of said Section 30 bears N. 07°50'00" W., a distance of 2,200.0 feet situated in Douglas County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Source:	Underground
Manner of Use:	Recreation and Domestic
Amount of appropriation:	*0.032 c.f.s., but not to exceed 12.0 acre-feet annually
Period of use:	January 1st to December 31st of each year
Date of priority of appropriation:	**1898

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well, 400 feet deep, 12¹/₄ inch diameter casing, equipped with a 25 H.P. submersible pump, thence through a distribution system to two water ski lakes (Dam Permits J-389 and J-419) for recreation and domestic purposes located within portions of the SW¹/₄ NW¹/₄, SE¹/₄ NW¹/₄, NE¹/₄ SW¹/₄, SE¹/₄ SW¹/₄, SW¹/₄ SW¹/₄, NW¹/₄ SW¹/₄, all within Section 30, T.14N. R.20E., M.D.B.&M.

*The total combined duty of water under Permit 57805, Certificate 14480, and any certificates issued under Permits 59294, 59295, 62334, 62335, 62336, and 62337 shall not exceed 100.01 acre-feet annually.

**This certificate changes the place of use of Permit 57539, which changed the point of diversion, place of use and manner of use of a portion of Permit 53593, which changed the point of diversion and place of use of a portion of Proof 04691, therefore, the date of priority remains the same as Proof 04691.


The water right issued under this certificate is dependent on the result of an adjudication of the water right under Proof of Appropriation No. 04691.

This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
