WHEREAS, Robert E. Firth, Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from the Truckee River through the Lake Ditch, for as decreed purposes. The point of diversion of water from the source is as follows:

Lake Ditch

NE¹/₄ NW¹/₄ Section 19, T.19N., R.19E., M.D.B.&M., or at a point from which the NE corner of said Section 19, bears S. 88°05'00" E., a distance of 2,620.00 feet situated in Washoe County, State of Nevada.

Under the provisions of NRS 533.425, the State Engineer has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Water is diverted from the Truckee River via the Lake Ditch, head gate and lateral and storage pond, thence pumped through a distribution system, including a holding tank, for sprinkler landscape irrigation of 0.74 acres within the NW¹/₄ NW¹/₄ Section 7 T.18N., R.20E., M.D.B.&M., and 0.35 acres within the NE¹/₄ NE¹/₄ Section 12, T.18N., R.19E., M.D.B.&M. (1.09 acres total), being further described as within a portion of Assessor's Parcel Number 043-062-08, Washoe County, Nevada.

*The total combined duty of water under Permit 66974, Certificate 17142 and any certificate issued under Permit 66975 shall not exceed 9.85 acre-feet as decreed for the irrigation of 2.53 acres.

**This certificate changes the point of diversion and place of use of a portion of Claim 191, Truckee River Final Decree, in United States v. Orr Water Ditch Co., In Equity Docket No. A-3 (D. Nevada 1944), therefore, the date of priority remains the same as Claim 191.
