CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Tom Driggs, Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and distribution system for irrigation purposes. The point of diversion of water from the source is as follows:

NW $\frac{1}{4}$ SW $\frac{1}{4}$ Section 4, T.20S., R.53E., M.D.B.&M., or at a point from which the W $\frac{1}{4}$ corner of said Section 4 bears N. 13°19'43" W., a distance of 713.7 feet situated in Nye County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Source:	Underground
Manner of use:	Irrigation
Amount of appropriation:	*0.03 c.f.s., but not to exceed 10.0 acre-feet annually
Period of use:	January 1st to December 31st of each year
Date of priority of appropriation:	**April 18, 1960

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well, 400 feet deep, 8-inch diameter casing, equipped with a 15 H.P. Franklin motor, Berkely submersible pump and totalizing meter, thence through a distribution system for pivot sprinkler irrigation of alfalfa on the following land:

**12.85 acres in the NW $\frac{1}{4}$ SW $\frac{1}{4}$ Section 4, T.20S., R.53E., M.D.B.&M.
12.34 acres in the NE $\frac{1}{4}$ SW $\frac{1}{4}$ Section 4, T.20S., R.53E., M.D.B.&M.
13.34 acres in the SW $\frac{1}{4}$ SW $\frac{1}{4}$ Section 4, T.20S., R.53E., M.D.B.&M.
12.48 acres in the SE $\frac{1}{4}$ SW $\frac{1}{4}$ Section 4, T.20S., R.53E., M.D.B.&M.
51.01 acres total**


*The water under Permits 75223, Certificate 17406; 75224, Certificate 17407; 75225, Certificate 17408; 75226, Certificate 17409 and Permit 75227, Certificate 17410 is commingled and the total combined duty shall not exceed 255.05 acre-feet annually for the irrigation of 51.01 acres within the above-described place of use.

**This certificate changes the point of diversion of Permit 73557, which changed the point of diversion and place of use of Permit 60604, Certificate 16063, which changed the point of diversion, manner and place of use of a portion of Permit 23943, Certificate 7040, which changed the place of use of Permit 18728; therefore, the date of priority remains the same as Permit 18728.

This certificate is issued subject to the terms of the permit with the understanding that the total duty of water shall not exceed 5.0 acre-feet per acre annually from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
