CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, James P. Hadden, Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and distribution system for irrigation and domestic purposes. The point of diversion of water from the source is as follows:

NE $\frac{1}{4}$ SW $\frac{1}{4}$ Section 15, T.12N., R.19E., M.D.B.&M., or at a point from which the S $\frac{1}{4}$ corner of said Section 15 bears S.9°11'54" E., a distance of 1,561.29 feet situated in Douglas County, State of Nevada.

Under the provisions of NRS 533.425, the State Engineer has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Manner of use:	Irrigation and Domestic
Amount of appropriation:	*0.04 c.f.s., but not to exceed 10.0 acre-feet annually
Period of use:	January 1st to December 31st of each year
Date of priority of appropriation:	**July 14, 1964

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well, 440 feet deep, 8-inch diameter casing, equipped with a 10 H.P. Franklin motor, Jacuzzi pump and totalizing meter, thence through a distribution system for sprinkler irrigation of 2 acres of pasture, drip irrigation of fruit trees, nut trees, grapes, and six small ponds with a total surface area of 0.19 acres, all located within portions of the W $\frac{1}{2}$ SE $\frac{1}{4}$ and E $\frac{1}{2}$ SW $\frac{1}{4}$ Section 15, T.12N., R.19E., M.D.B.&M., being further described as within portions of Assessor's Parcel Numbers 1219-15-002-028 and 1219-15-002-032, Douglas County, Nevada.


*The water under Permit 67588, Certificate 18252 and Permit 67589, Certificate 18253 is comingled and the total combined duty shall not exceed 18.18 acre-feet annually within the above-described place of use.

**This certificate changes the point of diversion, manner and place of use of a portion of Permit 52018, which changed the point of diversion and place of use of a portion of Permit 22099, Certificate 7777; therefore, the date of priority remains the same as Permit 22099, Certificate 7777.

This certificate is issued subject to the terms of the permit with the understanding that a change to conventional irrigation practices will cause this right to revert back to 4.0 acre-feet annually per acre of land irrigated.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
