CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Ron Murphy, Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and distribution system for irrigation purposes. The point of diversion of water from the source is as follows:

NW¹/₄ NW¹/₄ Section 10, T.20S., R.53E., M.D.B.&M., or at a point from which the NW corner of said Section 10 bears N. 43°17'19" W., a distance of 875.86 feet situated in Nye County, State of Nevada.

Under the provisions of NRS 533.425, the State Engineer has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator:	The Murphy Family Trust
Source:	Underground
Manner of use:	Irrigation
Amount of appropriation:	*0.0125 c.f.s., but not to exceed 5.0 acre-feet annually
Period of use:	January 1st through December 31st of each year
Date of priority of appropriation:	**October 9, 1952

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well, 460 feet deep, 8-inch diameter casing, equipped with a 30 H.P. Grunfos pump, Franklin motor, a 5,000-gallon storage tank and totalizing meter, thence through a distribution system for wheel line sprinkler irrigation of 1.0 acre of sudan grass and drip irrigation of trees located within a portion of the NW¹/₄ NW¹/₄ Section 10, T.20S., R.53E., M.D.B.&M., being further described as portions of Assessor's Parcel Numbers 035-111-23 and 035-111-24 Nye County, Nevada.


*The total combined duty of water under Permit 72109, Certificate 18585; Permit 72110, Certificate 18586; Permit 72183, Certificate 18587 and Permit 76183, Certificate 18588 shall not exceed 42.0 acre-feet annually.

**This certificate changes the point of diversion of a portion of Permit 64596, which changed the point of diversion and place of use of a portion of Permit 14576, Certificate 5329; therefore, the date of priority remains the same as Permit 14576, Certificate 5329.

This certificate is issued subject to the terms of the permit with the understanding that the total annual duty of water shall not exceed 5.0 acre-feet per acre of land irrigated from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
