## CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Robert E. Firth, Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from the Truckee River through the Steamboat Canal for as decreed purposes. The point of diversion of water from the source is as follows:

**Steamboat Canal**

NE<sup>1</sup>/<sub>4</sub> SW<sup>1</sup>/<sub>4</sub> Section 31, T.19N., R.18E., M.D.B.&M., or at a point from which the SE corner of said Section 31 bears S. 62°04' E., a distance of 3,195.0 feet situated in Washoe County, State of Nevada.

Under the provisions of NRS 533.425, the State Engineer has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Source:	Truckee River via the Steamboat Canal
Manner of use:	As Decreed
Amount of appropriation:	*0.0009 c.f.s., but not to exceed 0.218 acre-feet as decreed
Period of use:	As Decreed
Date of priority of appropriation:	**December 22, 1874 (Claim 179) April 7, 1876 (Claim 257)

Description of the works of diversion, manner and place of use:

Water is diverted from the Truckee River, through the Steamboat Canal and headgate, thence into a lateral ditch for irrigation of 0.19 acres and 0.15 acres of trees and shrubs located within portions of the SW<sup>1</sup>/<sub>4</sub> NE<sup>1</sup>/<sub>4</sub> and the SE<sup>1</sup>/<sub>4</sub> NE<sup>1</sup>/<sub>4</sub>, respectively, Section 20, T.19N., R.19E., M.D.B.&M., being further described as a portion of Assessor's Parcel Number 009-120-31, Washoe County, Nevada.


\*The water under Permit 77479, Certificate 18851 and Permit 77480, Certificate 18852 is commingled and the total combined duty of water shall not exceed 1.448 acre-feet as decreed for the irrigation of 0.34 acres within the above described place of use.

\*\*This certificate changes the point of diversion and place of use of a portion of Claim 179 and changes the point of diversion and place of use of a portion of Permit 11489, Certificate 4827; which changed the point of diversion of Claim 257, Truckee River Final Decree, in United States v. Orr Water Ditch Co., In Equity Docket No. A-3 (D. Nevada 1944), therefore, the dates of priority remain the same as Claims 179 and 257.

This certificate is issued subject to the terms of the permit with the understanding that the total duty of water shall not exceed 4.25 acre-feet per acre as decreed from all sources and is subject to the continuing jurisdiction and regulation by the Federal Water Master and the State Engineer.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
