CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Bruce R. Scott, Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and distribution system for irrigation and domestic purposes. The point of diversion of water from the source is as follows:

SE $\frac{1}{4}$ SE $\frac{1}{4}$ Section 22, T.16N., R.19E., M.D.B.&M., or at a point from which the SE corner of said Section 22 bears S. 01°09' E., a distance of 800 feet situated in Washoe County, State of Nevada.

Under the provisions of NRS 533.425, the State Engineer has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Source:	Underground
Manner of use:	Irrigation and Domestic
Amount of appropriation:	*0.0088 c.f.s., but not to exceed 6.394 acre-feet annually
Period of use:	January 1st through December 31st of each year
Date of priority of appropriation:	**August 20, 1962

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well, 360 feet deep, 6-inch diameter casing, equipped with a 3 H.P. Sta-Rite submersible pump and totalizing meter, thence through a distribution system for sprinkler irrigation of 1.755 acres of lawn and trees located within a portion of the SE $\frac{1}{4}$ SE $\frac{1}{4}$ Section 22, T.16N., R.19E., M.D.B.&M., being further described as a portion of Assessor's Parcel Number 055-200-25, Washoe County, Nevada.

*The water under Permit 73191, Certificate 18878 and Permit 73192, Certificate 18879 is commingled, and the total combined duty of water shall not exceed 7.02 acre-feet annually for the irrigation of 1.755 acres within the described place of use.

**This certificate changes the point of diversion of a portion of Permit 58374, which changed the point of diversion and place of use of a portion of Permit 20648, Certificate 6086; therefore, the date of priority remains the same as Permit 20648, Certificate 6086.

This certificate is issued subject to the terms of the permit, with the understanding that the total annual duty of water shall not exceed 4.0 acre-feet per acre of land irrigated from all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
