CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Robert O. Anderson, Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and distribution system for irrigation and domestic purposes. The point of diversion of water from the source is as follows:

SE¹/₄ SW¹/₄ Section 19, T.12N., R.20E., M.D.B.&M., or at a point from which the SW corner of said Section 19 bears S. 88° 46' 27" W., a distance of 2,316 feet situated in Douglas County, State of Nevada.

Under the provisions of NRS 533.425, the State Engineer has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Source:	Underground
Manner of use:	Irrigation and Domestic
Amount of appropriation:	*0.3686 c.f.s., but not to exceed 268.51 acre-feet annually
Period of use:	January 1st through December 31st of each year
Date of priority of appropriation:	**November 5, 1964

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well, 304 feet deep, 8-inch diameter casing, equipped with a 15 H.P. motor, Goulds pump and totalizing meter, thence through a distribution system for flood irrigation of pasture grass on the following land:

**0.68 acres in the SE¹/₄ SE¹/₄ Section 24, T.12N., R.19E., M.D.B.&M.
 34.75 acres in the SE¹/₄ SW¹/₄ Section 19, T.12N., R.20E., M.D.B.&M.
 34.67 acres in the SW¹/₄ SW¹/₄ Section 19, T.12N., R.20E., M.D.B.&M.
 70.10 acres total**


*The total combined duty of water under Permit 70883, Certificate 18921 and Permit 70884, Certificate 18922 shall not exceed 280.40 acre-feet annually for the irrigation of 70.1 acres. Permit 70883, Certificate 18921 and Permit 70884, Certificate 18922 are issued totally supplemental to Claims 602 and 603 of the Carson River Final Decree.

**This certificate changes the point of diversion of Permit 61468, which changed the point of diversion, manner and place of use of a portion of Permit 52030, Certificate 13059; which changed the point of diversion of Permit 22314, Certificate 7707; therefore, the date of priority remains the same as Permit 22314, Certificate 7707.

This certificate is issued subject to the terms of the permit with the understanding that the total annual duty of water shall not exceed 4.0 acre-feet per acre of land irrigated from all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
