

STATE OF NEVADA**CERTIFICATE OF APPROPRIATION OF WATER**

WHEREAS, Chris N. Facque, Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from the Truckee River through the Largomarsino-Noce Ditch for industrial purposes. The point of diversion of water from the source is as follows:

Largomarsino-Noce Ditch

NE $\frac{1}{4}$ SE $\frac{1}{4}$ Section 18, T.19N., R.21E., M.D.B.&M., or at a point from which the NE corner of said Section 18 bears N. 21°30' E., a distance of 3,602.0 feet situated in Washoe County, State of Nevada.

Under the provisions of NRS 533.425, the State Engineer has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Description of the works of diversion, manner and place of use:

Water is diverted from the Truckee River through the Largomarsino-Noce Ditch, pipeline, Baldor 40 H.P. motor, Coker AC-2000 pump, 4" pipeline, pond, and distribution system for dust control and aggregate washing at an asphalt production plant located within Section 7, portions of the SW $\frac{1}{4}$ NW $\frac{1}{4}$ and the NW $\frac{1}{4}$ SW $\frac{1}{4}$ Section 16, and the N $\frac{1}{4}$ and a portion of the S $\frac{1}{4}$ lying north of the northerly right-of-way line of I-80, all located within T.19N., R.21E., M.D.B.&M., being further described as within a portion of Assessor's Parcel Numbers 084-060-37, 084-060-38, 084-070-11, 084-070-19, 084-080-20, 084-080-22, and 084-080-30, Washoe County, Nevada.


****The issuance of this certificate fully abrogates 17.16 acre-feet per season associated with 4.29 acres under Truckee River Claim 67 as described in the exiting place of use. The issuance of this certificate is for the consumptive use portion only, being 2.5 acre-feet per acre of the base right. The remaining portion of the base right will remain in the river for use by other decreed right holders.**

****This certificate changes the point of diversion, manner and place of use of a portion of Claim 67, Truckee River Final Decree, in United States v. Orr Water Ditch Co., In Equity Docket No. A-3 (D. Nevada 1944); therefore, the date of priority remains the same as Claim 67.**

This certificate is issued subject to the terms of the permit and subject to the continuing jurisdiction and regulation by the Federal Water Master and the State Engineer.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
