TO THE CITIZENS OF THE STATE OF NEVADA

This planning report entitled "Nevada State Water Planning References" is provided as part of the on-going Nevada water planning effort. Close to 1,000 references have been selected for listing, largely from the bibliography sections of previous State Water Plan reports.

References listed have found use in some aspect of the Water Plan to date. Purposes of publishing the reference list are primarily public service and historical. A reference listing is useful in answering inquiries by citizens, who have provided tax funds to support water planning. Present and future researchers may examine published aspects of the water planning effort from pre-set points of view. Others may want to gain perspective upon existing and projected relationships among resource use, economic activity and population.

It should be emphasized that obtaining reports produced by others was no easy task for the planning staff at the Division of Water Resources. Many of these reports were received on loan, have long since been returned to their sources and are not available for review at the Division. Reviewers must take this situation into account in pursuing a difficult but hopefully rewarding task. Suggestions on approaches for obtaining reports listed are offered in the Introduction.

INTRODUCTION

This report has been organized to present selected references principally according to place -- the geographic extent associated with the subject under investigation. Accordingly, a map showing selected references has been provided in the cover pocket. Non-geographic organization is intended to be provided by the individual reviewer.

Some broad concepts of organization which reviewers might use in pursuing investigations with the references provided would include:

Organization of References

Author:	Person or agency responsible for publication
Title:	Reference identification
Subject:	Broad topic related to water planning under which a number of reference titles may be grouped for systematic study
Place:	Geographic extent associated with the subject of investigation
Time:	Period of time involved which can be related to reference title, place or date of publication.

Data in this report are divided into three geographic classifications. The first is geared to references concerning specific basins (valleys or hydrographic areas) and groupings thereof; the second presents references of a statewide nature and references related to a broad general topic; the third provides references of national and international significance or origin.

References geared to specific geographic areas are uniquely numbered. The same numbers are printed in red on the map located in the cover pocket. Subject matter of these references is usually confined to basins(s) or other identifiable areas within the State. Some references overlap into neighboring states.

References of a statewide nature or related to a broad general topic are not numbered and consequently are not indicated on the map.

References of national and international significance or origin might generally apply to Nevada, in concept, or might have specifically applicable information. As with the second classification, the references are not numbered and are not indicated on the map.

The history of water resource planning by private and public entities goes back many years in the State of Nevada. However, only those reports having been recently useful in various State Water Plan publications are listed herein. This report is intended for use as a selective listing of Nevada water planning references.

Obtaining many of the references listed may be difficult. Due to the unavoidable distribution and loss of reports with time, it was not practical to list individually where each report might best be obtained. Very few reports listed are available from the Division of Water Resources. Most reports were received on loan and have long since been returned to their sources.

The best sources of reports in Nevada are persons or agencies responsible for publication; then the State Library in Carson City and the main and specialized libraries on the campuses of the University of Nevada at Reno and at Las Vegas. These libraries can handle distribution of reports to the smaller libraries statewide.
