RULING

GENERAL

Application 37355¹ was filed on March 30, 1979, by Mildred L. Hedges to appropriate 5.4 c.f.s. of water from an underground source to irrigate 320 acres of land within the E1/2 Section 1, T.34N., R.57E., M.D.B.&M. The point of diversion is described as being within the SE1/4 SE1/4 Section 1, T.34N., R.57E., M.D.B.&M.

FINDINGS

I.

Records and information² available to the State Engineer indicate that Application 37355 was filed in support of Desert Land Entry application.

II.

By letter³ dated December 13, 1983, the United States Department of Interior, Bureau of Land Management, notified the State Engineer that the following Desert Land Entry Application had been closed and the case file is dead.

III.

The applicant under Application 37355 does not own or control the land described under the place of use of the application.

CONCLUSIONS

I.

The State Engineer has jurisdiction⁴ over the matter described herein.

II.

Application 37355 was filed in support of Desert Land Entry. The Desert Land Entry application described under III of Findings has been closed on the records of the Bureau of Land Management, therefore, the applicant does not own or control the land described under the place of use of the application and cannot demonstrate the ability to place the water to beneficial use.

III.

To grant application to appropriate the public waters for irrigation on lands the applicant does not own or control or where the applicant cannot demonstrate the ability to place the water to beneficial use, would not be in the public interest and welfare.

RULING

Application 37355 is herewith denied on the grounds that to grant the application for irrigation purposes on lands that the applicant does not own or control and cannot demonstrate the ability to place the water to beneficial use, would not be in the public interest and welfare.
